- (1) Fortnightly Reporting Cycle (1-15th; 16-end of Month)
- (2) Airline to upload Billing File by xx hrs in CASSLink for processing. Note that any Billing Files uploaded after these dates will only be processed in the next billing period.
- (3) Known as (BP) Billing Period -CASS Invoices & Billing Statement (BS) available for downloading from CASSLink, Output Services, Output Airlines/Output Agents, View PDF
- (4) **Agents can request a correction**
- (5) **Deadline for Airlines to respond to correction requests**
- (6) Known as (CP) Correction Period -Final invoice will only report all correction documents processed in CP. Adjust total amounts owed to/from Agents and Airlines for Remittance and Settle Invoice will only contain adjustments, if any. Where there are no corrections, a new BS will be generated, same as the one received in BP
- (7) Agents' Remittance Date. Late or incomplete payment will result in applying the Rules as per Resolution 801r, Section 2.
